

Bank Rakyat Term Deposit-i “Eight Triple One Eight” (Individual) Campaign Year 2021

Terms and Conditions

A. Campaign Eligibility

1. This Campaign is only open to the following individual with Malaysian citizenship including Permanent Resident (PR):
 - a) EXISTING Term Deposit-i depositors (individual, joint and trustee);
 - b) EXISTING customers who hold or subscribe any products of Bank Rakyat.

Bank Rakyat employees are EXCLUDED from this Campaign.

B. Campaign mechanism:

- a) Fund Placement

Term Deposit-i (Individual) minimum placement of RM10,000 for a period of 8 months, 11 months or 18 months by depositor/customers.

- b) Profit Rate

- i. Profit rate for the following tenure under this campaign are detailed as follows:

Tenure	Profit Rate
8 months	2.48% p.a.
11 months	2.58% p.a.
18 months	2.78% p.a.

Disclaimer: The campaign profit rates may be revised accordingly to reflect changes in the Overnight Policy Rate (OPR) as set by Bank Negara Malaysia (BNM), if any shall occur during the campaign period.

- ii. The profit rate under this campaign is applicable for deposit placement of ONE (1) cycle only during the campaign period.
- iii. Upon maturity and subject to instruction by depositors/customers during opening of the account, the Bank may automatically renew in accordance with the same tenure based on the Bank's prevailing profit rate.
- iv. Depositors/customers may choose manner of profit payment either on a MONTHLY basis or UPON MATURITY of the Term Deposit-i.

- v. Depositors/Customers are required to open Bank Rakyat Savings Account-i or eCurrent Account-i (eCA-i), whereby all profit payments or withdrawal will be credited to their Bank Rakyat Savings Account-i or eCA-i.
- vi. Premature withdrawal is allowed only in full. No profit will be paid to the depositor/customer. If the depositor/customer chooses to receive profit on a monthly basis, the Bank reserve the right to make necessary adjustment on the monthly profit and/or principal amount of TD-i.
