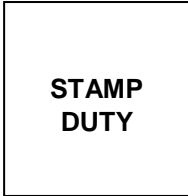

I/We refer to my/our above eCA-i Account with your Bank and hereby notify you that in exercise of my/our authority as individual/sole proprietor/partners thereof, I/we have empowered

And I/we hereby also notify you that I/we have authorised the said person(s) on my/our behalf to make, draw, accept or otherwise sign any bills of exchange, promissory notes, orders for payment or other negotiable instruments, and to discount them with your Bank or otherwise, and also to endorse cheques or other negotiable or mercantile instruments of any description, and I/we hereby acknowledge and hold myself/ourselves liable thereon jointly and severally in the same way as if they were signed by me/us.

In the event of any change of instructions, countermanding instructions are received by the Bank in respect of any accounts, including but not limited to individual account holders, joint account holders, sole proprietors, partners, authorised signatories in any of the aforementioned accounts OR where there are changes in the constitution of the joint account holders / sole proprietorship / partnership (whether due to events of death, resignation, insolvency or incapacity or otherwise) OR where in the sole opinion of the Bank, there is evidence of a dispute in relation to any accounts including but not limited to the abovementioned accounts, the Bank may but shall not be obliged to comply with any instructions received from any of the account holders or persons authorised under those accounts until the Bank receives written instructions from (where applicable) me (individual account or sole proprietor account); all the joint account holders; all the partners in the Bank's records OR may proceed to close the account as per the General Terms & Conditions of Accounts. I/We shall at all times remain liable for all existing and accruing outstanding sums in my/our account.

I/We and the authorised signatory hereby agree to be bound by the terms of this Mandate and the General Terms & Conditions of Accounts and hold you free from liability / indemnify you in respect of the Bank's actions or any hold placed as set out above. Any charges or expenses incurred by the Bank as a result of complying with my/our instructions will be debited to my/our account.

This authority shall continue in force until you have received from me/us a notice in writing revoking this authority.
