

# TERMS AND CONDITIONS ADIK SIMPAN ADIK SENANG CAMPAIGN

The Adik Simpan Adik Senang Campaign (the Campaign) is organised by Bank Rakyat.

By participating in the Campaign, the eligible participant (as defined below) shall have thoroughly read and fully understood all the Terms and Conditions herein and fully agrees to be bound by and accept all the Terms and Conditions contained herein.

### A. <u>Campaign Eligibility</u>

- 1. This Campaign is open to all new and existing customers of Bank Rakyat who meet the following criteria (eligible participant):
  - i. Malaysian citizens, including Permanent Resident (PR).
  - ii. Individuals aged 18 years old and below.
  - iii. Holders of individual account, joint accounts and trust accounts.
  - iv. Bank Rakyat employees (main account holders for joint accounts or trust accounts) are eligible to participate in the campaign, except for employees involved that involved in the winner selection process or committee.
- 2. Individuals with any arrears, defaults or suits against existing facilities or financing with the Bank during the campaign period are NOT eligible to participate in this campaign.

#### B. Campaign Period

- 1. The Campaign period is from 1 July until 31 December 2024.
- 2. Bank Rakyat may change or amend the Campaign period (extend, shorten or discontinue) if necessary at any time.
