

# **TERMS AND CONDITIONS**

# RAKYAT REWARDS POINTS REDEMPTION PROGRAM AND DONATION TO THE NATIONAL CANCER SOCIETY OF MALAYSIA

#### A. **ELIGIBILITY AND PARTICIPATION**

 The Rakyat Rewards Points Redemption Program and donation to National Cancer Society Malaysia are open to all Bank Rakyat Credit Card-i holders INCLUDING Bank Rakyat's employees.

#### B. <u>EFFECTIVE PERIOD</u>

1. The Program will commence on 17 March 2025.

## C. PROGRAM CRITERIA

- 1. The Rakyat Reward Points conversion applications will **ONLY** be available through iRakyat.
- 2. **A minimum of 3,000** Rakyat Rewards Points is required to initiate the redemption.
- 3. Redemption can **ONLY** be made for every **3,000** accumulated Rakyat Rewards Points.
- 4. All redemption points donated to National Cancer Society Malaysia will be channelled to support the Human Papillomavirus (HPV) Program. This program is a vaccination initiative aimed at raising awareness and providing HPV vaccinations to prevent cervical cancer among teenagers from low-income, middle-income and disadvantage families across Malaysia.
- 5. Donations as low as RM30 are eligible for tax exemption. The National Cancer Society Malaysia will provide a donation receipt to the cardholders via the registered email.
- 6. The information that will be provided to the National Cancer Society Malaysia for the issuance of a receipt as follows:
  - a) Name
  - b) Cardholder's address
  - c) Date and amount of donation and
  - d) Registered email address.
- Redemption and conversion of Rakyat Reward Points to the National Cancer Society Malaysia will take approximately 4 business days from the date of the redemption order.
- 8. The Rakyat Reward Points accumulated in the principal and supplementary cardholders' accounts can only be redeemed by the principal cardholder.
- 9. The Rakyat Reward Points are only valid for redemption after Rakyat Reward Points have been awarded.



- 10. Bank Rakyat shall not revise or reverse any **SUCCESSFUL** redemption or conversion of Rakyat Reward Points to the National Cancer Society Malaysia.
- 11. If the transfer of Rakyat Reward Points is **UNSUCCESSFUL or REJECTED**, Bank Rakyat will not be obliged to effect manual transfer. The Rakyat Reward Points will not be deducted and cardholders may be able to perform the next redemption transaction in **4** business days from the date of the last redemption order.
- 12. Bank Rakyat reserves the right to change the conversion rate with at least **21** calendar days prior notice to cardholders via Bank Rakyat's official website or any other channels deemed fit by Bank Rakyat.
- 13. Cardholders may view their points accumulation via iRakyat. Please refer to item (D).

# D. ONLINE RAKYAT REWARDS REDEMPTION VIA IRAKYAT

- 1. Cardholders are required to register in iRakyat internet banking.
- 2. Cardholders may follow the steps below for Rakyat Reward Points conversion to donate to the National Cancer Society Malaysia through iRakyat: -
